The meeting was called to order at 6:01 p.m. by LaMar with the Pledge of Allegiance.

November 2023 minutes approved. Motion: LaMar/Lee. Carried 3-0.

Treasurers Report given by Novak.

Cemetery Report by Garman. Flags placed by maintenance for candle marking.

Maintenance Report by Lee. DR brusher needs replacing. Lee expresses her appreciation for all the work done for the ice candle celebration and more by maintenance, clerk, and deputy clerk. Brushing, rink liner, and more discussed.

Road Report by Lee. Grader operator checked roads and looking good at this time. Rock on Hanka Nevala addressed. St. Louis County snow plowing invoice for 1st partial payment to be paid.

LaMar spoke on rink liner and advertisers he has found to cover the cost of liner.

Carissa Smith speaks on behalf of the Fair Winter Fest coming up in January. Looking for township collaboration in making this a great community event. Rink and sliding hill will be reserved on January 20 for the event, per township supervisors. Volunteers to help with the event are wanted if there is interest, meeting will be held on December 19.

Board meeting conduct presented by LaMar. Discussion on running a board meeting with basic rules. Clerk presented resolution. Tabled for review.

Clerk struggles with minutes, informed supervisors that by law it is not a complete transcript of the meeting but rather motions made and a brief description of discussions and public comments need not to be included word for word making minutes longer than needed. *Motion: LaMar/Lee to post in*

Flying Finn that minutes will be motions made and brief description of topics on agenda. Carried 3-0.

Fire Department asking for township to transfer deed over for the very small piece of land in front of department. *Motion: Lamar/Lee to authorize Lee to call attorney to get information to resolve the matter. Carried 2-0. Garman abstains.*

Flying Finn costs discussed. Ads sent by local organizations has been done at no charge, discussion on asking organizations to pay for advertising or possible donation. Spreadsheet will be created by Clerk, tabled.

Canister Site lease discussed and Lee to contact St. Louis County and inquire on the yearly lease of \$300 and the possibility for an increase.

Ice Candle traffic control discussed by Lee. EVFD volunteering to help with traffic control. *Motion: Lee/LaMar to make \$300 donation to EVFD. Carried 3-0.*

DPS invoice for concrete work to be done in spring/summer months. *Motion: LaMar/Garman to not pay until work is complete and FEMA funds received. Carried 3-0.*

Motion: Lee/LaMar to purchase an AED (Automatic External Defibrillator) for the townhall as soon as fiscally possible. Carried 3-0.

Motion: Lee/Garman for clerk to contact credit card company to make a one-time increase limit on card to purchase Starlink. Carried 3-0.

Knuti discusses the National Registry of Apostolic Church and to be placed in the Flying Finn.

Pyhala property. Knuti would like the township to take steps into restoration work. Knut is looking for guidance on the townships interest in moving forward. Lee speaks that township budget is not in shape to do so and needs public support if were to go forward. Lee appreciates the passion Knuti has for the property. Knuti informed would volunteer to write a request for funding help with Clerk's help. LaMar speaks and supports the Pyhala being restored. Lee speaks we have much to maintain already. Knuti if township doesn't have interest in maintaining then should sell.

Meeting was called to order at 7 p.m. by Board Chair, Mike Johnson and was followed by the Pledge of Allegiance.

Minutes Approval: *Steve moved to approve the October 4, 2023 Meeting Minutes. Mike supported. Carried (3-0).*

Treasurer's Report: No receipts for October. Disbursements totaled \$1,773.10. *Eric approved the Treasurer's report with Steve supporting. Carried (3-0).*

Approval to Pay Bills: *Eric moved to approve payment of the bills listed below plus payroll and PERA with support from Steve. Carried (3-0).*

Road Report: Township roads seem to be in good condition but snow covered at this time. Flood damaged Niemi Road was repaired. Steve Scheuring lowered the new culvert, as recommended by FEMA and added 4 inches of Class 5 to the problem area.

Cemetery: Steve has been doing fall clean-up. The water and trash barrels have been put in storage. Most people have removed decorations and planters from graves. Two footstones and a headstone have been installed recently.

Old Business: FEMA applications are nearing completion for the Niemi Road spring flooding. Rock, Sand & Fire has completed the work just in time before the freeze up. We are hoping for approximately \$300 in reimbursement of our hours. Waiting on instructions as how to apply for it at this time.

New window blinds for the office and the main meeting room have been ordered and received.

MATIT (insurance) gave us a price quote for added coverage for the new hall windows which were installed. *Mike moved*

to go with the \$2,500.00 deductible, with support from Steve. Carried (3-0).

New Business: The clerk has worked up a tentative 2024 Board Meeting Schedule. It will be adopted at the January Reorganizational Meeting.

Eric plans to take the LBAE online training before February 1st. Mike and Steve have current certificates.

When the Clerk is unable to take meeting minutes in January, the person filling in will receive \$50.00 per meeting.

Steve reported that the snowblower is now ready for use and the lawn mowers have been winterized. Eric stated he is willing to remove snow at the hall this winter.

Hall improvements were discussed. It was decided to contact and obtain at least 2 price quotes to install new LED ceiling lighting. Mike and Eric will be working on this. Mike will enclose the hole behind the refrigerator. The Ladies Room is in need of remodeling, hopefully in time for the PNP Election in March. Work will be done by volunteers.

CELEBRATING A MILESTONE

On October 23, 2023, the Finnish Apostolic Lutheran Church in Embarrass was officially added to the National Register of Historic Places. The submission of the site and structure sitting on the hillside on the north side of County Road 21 was sent to the National Park Service - Department of the Interior for approval from the Minnesota Historical Society. After two years of hard work, Embarrass has another cultural location listed on the National Register. (Others include the Phyla homestead, Hanka homestead and the sauna at the Nelimark homestead.) The process of application was not an easy one; it is a difficult task to have a 100-year-old standing church approved as a national historical site. It's quite an accomplishment.

"The documentation for the request to make the church a historic site was wonderful and complete," stated Paul Knuti, who spearheaded the project for Sisu Heritage and the community. "It was approved mainly because of the work done over the past three years to preserve the historic structure; the foundation work to ensure adequate drainage and the roof eave additions made last year were what made the big difference for state and national approval. What we have accomplished here does not only place Embarrass on the map statewide but nationally as well. It's for the country!"

The church was the first built in the community, constructed in 1904 and used by the congregation over the last 100 years. It was donated to Sisu Heritage several years ago by the remaining families in the congregation, for preservation and safekeeping. It has been used for weddings, funerals and community concerts over the past years. The outstanding sound transfer from the rounded ceiling structure makes a musical concert a pleasurable experience for those in attendance.

A full-house community celebration took place on September 2, 2023, at the church. Musicians Eli Bissonett and Robin Anders presented a concert, with coffee and cake afterward for those in attendance to enjoy. Eli's ancestors had been members of the church and it was a special occasion for him and his family. Folks from Embarrass and surrounding communities came to help celebrate another Embarrass milestone of historic preservation. Hopefully the Apostolic Lutheran Church will continue to be well used for the next 100 years.
