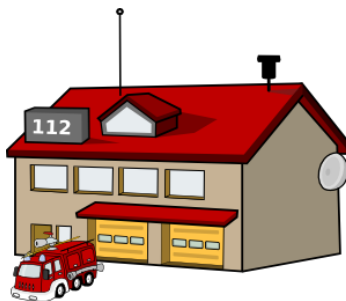

Meeting was called to order at 6:02 p.m. by Worsham with The Pledge of Allegiance.

*November minutes approved as printed*  
*Motion/Worsham: Second/Wright. Carried 3-0.*

*Treasures report was accepted after a question was asked about campground fund.*  
*Motion/Worsham: Second/Wright. Carried 3-0.*

Supervisors thank Bonnie and Roger Davies for the making of all the candles for the Ice Candle Celebration. Worsham points out he approved gift cards for them to show appreciation for all their hard work.

*Motion/Worsham: Second/Rantala to donate \$50 to the St. Louis County Fair. Carried 3-0.*

Letter regarding the Pyhala was drafted by clerk and Wright. After being reviewed by the supervisors and the visitors, Kunti asks for wording to be added to the letter to which the supervisors agree. More discussion was had on the topic. More files and information will be looked into. The board supervisors would like the letter sent to residents and registered voters of Embarrass for opinions on to sell or not. Supervisors would also like to hold a public meeting with the public at a later time. Knuti hands supervisors a description and informational sheet of the Pyhala history.

Meeting was called to order at 7 p.m. by Board Chair, Mitch Lind and followed by the Pledge of Allegiance.

**Minutes Approval:** *Steve moved to approve the October 8, 2019 Regular Meeting Minutes. Mitch supported. Carried (3-0).*

**Treasurer's Report:** October Receipts were \$19.94 (MV Credit-Ag) from State of MN, \$1,600 (Annual Lease Fee for Twp. Property for Wells) from Twin Metals. October Disbursements were: General Fund: \$1,245.51, Road & Bridge Fund: 0, Building: 0, Cemetery Fund: 0. *Steve accepted the report and Mitch supported. Carried (3-0).*

- Joki, David, \$300.00, Digging Marion Saranpaa Grave (Casket)
- Lake Country Power, \$72.60, Electricity for Town Hall

- Sipola, Steve, \$16.24, Mileage Reimbursement—Road Inspections

*Mitch moved to approve payment of all bills listed plus board payroll and PERA. Steve supported. Carried (3-0).*

**Address Visitors:** A resident had made a phone complaint to the Clerk about his road on October 28 but did not leave his name or state which road he had an issue with and it was unsettling to the clerk. The caller was present at the meeting and told the board he's been upset over the condition of Taapa Road. He said it hadn't been graded all summer or fall and there were times he had to fill in holes himself. He has even had balance issues to his car. Mitch told him grading was ordered on his road after his complaint. The resident also stated that the snowplowing service has been poor. Others in the audience agreed. The resident made an apology to the clerk for way he spoke in his phone message to her.

**Road Report:** Steve did inspections of all roads on October 10, after the complaint about Taapa Road. Taapa, Beckman and Teinila Roads were ordered graded on or around October 9 and again on or after October 29, according to St. Louis County. The township roads are presently in a frozen condition.

**Cemetery Report:** The clerk has been in contact with the sexton, he reported that he moved the trash and water barrels into the shed for the winter. He had two burials this month, Marion Saranpaa and Melvin Luhta.

**Old Business:** The road inspection check list was reviewed. Mike is willing to type a new form.

**New Business:** *Mitch moved to allow the clerk and the appointed Head Judge to attend Election Training in Virginia on December 10 for the March 3, 2020 Presidential Nomination Primary. Steve supported. Carried (3-0).*

Mike volunteered to download the app to monitor the propane tank from his phone. *Clerk's note: Superior Fuel Company will be monitoring also and will deliver as needed.*

The review of cemetery lot and sexton services will be tabled until the Re-Organizational Meeting.

A request for renting the hall by the Nate Bjork family on November 26-27 was approved provided they can show proof of insurance and a \$100 deposit check.

**Correspondence:** All other mail was read and filed. In addition, the clerk reported that she received a nice call from Linda Pulkinen, stating how pleased her family is with the work that has been done to Niemi Road. She wanted the thank you extended to the whole town board.

**Adjournment:** *Steve moved to close the meeting at 7:55 p.m. and was supported by Mitch. Carried.*

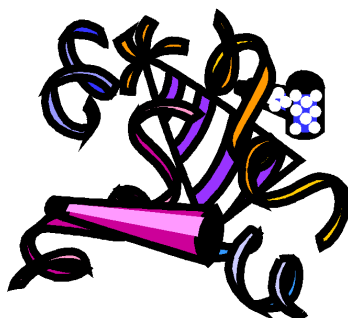

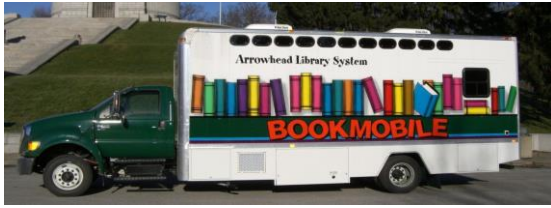

2. Cindy requested we pay \$105.00 to the East Range Shopper, motion by John, second Pat. October financial report was presented, motion to accept John, second Leone. September report accepted due to not having a quorum, motion John, second Jack.
