

# Town of Embarrass

## Board Meeting

April 10, 2019

### PENDING BOARD APPROVAL

Present: Zane Beaton, Roy Worsham, Gary Rantala, Mary Novak, Jennifer Boese

Visitors: Paul Knuti, Roland Fowler, Jack LaMar, Bill Wright

Meeting was called to order at 6:01 by Zane Beaton with the Pledge of Allegiance.

*Approval of March 13 minutes after correction of time (Motion/Gary: Second/Zane) Carried 3-0.*

*Treasures Report accepted (Motion/Beaton: Second/Rantala) Carried 3-0.*

Rantala gives road report. Roads are muddy at this time but in pretty good shape considering. Too early to tell if gravel is needed. Worsham points out Hanka Nevala Road culvert was frozen up but the county did go and thaw it out.

Clerk advised the board that a campground caretaker is still needed but we may have an interested couple. Jack LaMar also states he may know someone that may be interested. Clerk will send information with the job descriptions. Mary Novak spoke with another campground about running campground without a caretaker and described what they have done to keep things running smoothly.

Clerk reported to the board she spoke with Mike Salo and he is planning on returning as the tour guide in late May. Paul Knuti expresses to the board that tours are not being promoted. He suggests having the tours start at the Nelmark instead of the Visitor Center. Novak voiced her concerns with the start of the tours remaining at the Visitor Center. Stating that while the tour guide is waiting and getting paid to sit and wait for a possible tour patron at the Visitor Center, the bathrooms get cleaned, the brochures get stocked and other work is done. Being that maintenance doesn't work on weekends this helps keep the area clean. Knuti also believes there needs to be some

sort of signage for tours and some sort of one page brochure to send out. Knuti would like to see the two boards work together and figure out some sort of budget to get some of these ideas done. Worsham would like to speak with SISU about the lease. Worsham pointed out his concerns on plowing and that the township should not be responsible plowing. Beaton would like to reevaluate what needs to be done. Jack LaMar, Vice President of SISU, will deliver the message to Marlin Bjornrud, President of SISU, to see if something can be set up so the boards are able to meet. LaMar also mentions that at the last SISU meeting there was discussion held on the topic of communication between the two boards. The board is aware that Wednesday's are not good evenings to meet with Bjornrud. Knuti re-asked the question if the board is going to make a commitment to promote the tours and do something to increase the tours. Roland Fowler speaks and says until the two boards meet no decisions should be made. Board feels it shouldn't all be on the township that SISU should be a part of this and meeting with them should resolve many issues. SISU meetings are the third Monday of every month at 6:30 p.m. The board supervisors plan to attend the SISU meeting.

Maintenance report was given by Worsham. Moving of snow on township properties. Skating rink kept clear and heating shack stocked with firewood. Rink was closed 3/12/19. Blower unit removed from John Deere and brush unit attached. Info Center building cleaned and vacuumed. Worked on ice dams at the Town Hall rear of building. Pole barn was prepped for work area construction. Set up and break down of various meetings. Continuation of regular daily maintenance duties. Worsham points out that the Husqvarna riding lawnmower needs a new transmission. *Approved to have the lawnmower repaired at Grande's. (Motion/Worsham: Second/ Beaton) Carried 3-0.* Bad boy lawnmower was discussed and the estimates that Worsham received. Bill Wright commented that he knows someone and may be able to get the bad boy mower at a lower price and possibly even delivered. Worsham spoke about the estimates he received for grader tires and proposed that we get two for \$2523.78 from Pomp's Tire Service. *Purchase the two tires for the grader. (Motion/Beaton: Second/Rantala) Carried 3-0. Clerk to advertise for two*

*summer hires. (Motion/Zane: Second/ Worsham) Carried 3-0.*

Novak speaks and explains she was at the Iron Range Tourism meeting. Novak presents the board with the advertising sheet that the Heritage Park Campground is advertised in. She asks the board if they would like here to create a new logo for the Heritage Park Campground she would be more than willing to design a new one and if they had any ideas on what they would like. Board thinks it would be ok if Novak wanted to create something. Novak also talked with an editor of the Mesabi Daily News/ Hibbing News and was advised about getting information in for any Embarrass events that the township may have. Novak thinks this would be a good opportunity to get something in about the tours. Novak shows a list of where brochures are distributed, suggesting that the board has something smaller not so expensive made to be given out. The current brochure was discussed and was pointed out that some changes should be made and there may be grants to help with the costs of printing.

*Renew the liquor and tobacco license for Trapline. (Motion/Rantala: Second/Beaton) Carried 3-0.*

Worsham commented on the Tower Ambulance meeting that the clerk and Worsham attended on April 1, 2019. Worsham spoke with other local ambulance services and provided feedback. *Drop any further discussion with the Tower Ambulance Service at this time. (Motion/Rantala: Second/Zane) Carried 3-0.*

Worsham mentioned the Welcome to Embarrass signs that were taken down by St. Louis County. They were taken down and if the township wants them back up they have to be purchased for \$500 a piece and all they will say is Embarrass Township, then in ten years they will be taken down again and the township will be given the choice to pay for them again to be put back up. That is the counties new policy. Rantala explains about signs for historical properties on Hwy 21 and Hwy 169, he was advised that no permit is needed for under 6 square feet. Any sign that is put up must not impair the vision of passing vehicles and we would need the permission of the land owner. Worsham replied he spoke with the State about tourism signs and they replied with no they will not be funding any signs. Knuti suggests the township come up with some sort of sign that should be put up promoting tours.

Beaton speaks about getting a new computer for Clerk's Office and also believes should have someone come in to make sure everything is transferred from old computer to the new one when it is purchased.

LaMar informs the board he did put together a YouTube channel and it does have the Ice Candle Celebration on it. LaMar has also finished a grant application to fund a continuation of the video series he is working on.

Knuti asks about the foundation at the Pyhala Homestead and if the board has done anything. Worsham answered that he has spoken with a grant writer and she has four different proposals for grants and will be attending the May meeting. Knuti asks the board what they want to do with the \$3,800 quote that he sent the board on the condition assessment proposal. Worsham would like to put the proposal on hold until the grant writer is spoken with. Knuti argues that it should not be put on hold. The board feels that \$3,800 is a lot of money for an assessment of how bad the condition of the house is. Wright commented on how bad the condition of the house is. Fowler also commented on the condition and says there is absolutely nothing that can be fixed on the house. Knuti says we need to get professional assessment done and believes it is a shame nothing has been done in twenty five years. Fowler expressed that wasn't true. Wright has been inside the house and says a lot of money has been sunk into the house and without heating and maintaining it all the time there is no point in putting a dollar into the house. Beaton mentioned he has had residents communicate with him and they would like the township to watch what money they are spending on historical properties. Doesn't make sense to spend \$3,800 on someone to tell us the Pyhala house is in terrible shape. Beaton also feels it is a hazard along with others he has spoken with. Fowler responded there is no way to protect it because it has been labeled as a haunted house and that vandalism will continue no matter what we do to it. We don't have the personnel to be there to protect it and there is nothing to protect at this time. Rantala replied if we look at it through a historical property then yes it should be saved but if we look at it like a cost benefit then I don't know if it is worth saving. The work that has been done was to primarily save the barn, sauna and wood shed. Wright advised the board that alot of grant money was spent to fix just the sauna. Some feel that this may have been important to residents back then but times have changed and it may not be a priority to residents now. LaMar encourages the board to look around and speak with residents. More discussion was held on the Pyhala House and the proposal. *Table the condition assessment proposal on the Pyhala House. (Motion/Beaton: Second/Worsham) Carried 3-0.*

Small discussion was held on the May clean up. Clerk will get in contact with locals to ask for help cleaning the roads in the township.

*Accept the claims and correspondence (Motion/Beaton: Second/Worsham) Carried 3-0.*

*Roy adjourns the meeting at 7:38 p.m.*

## Waasa Township Regular Board Meeting Tuesday, March 5, 2019

**Board Members Present:** Mitch Lind, Phil Hebl, Steven Sipola, Bonnie Keller and Sandra Gibson

**Visitors:** Dean DeBeltz and Carroll Eckman

Meeting was called to order at 7 p.m. by Board Chair, Mitch Lind followed by the Pledge of Allegiance.

**Minutes Approval:** *Phil moved to approve the February 5, 2019 Regular Meeting Minutes. Mitch supported. Carried (3-0).*

**Treasurer's Report:** \$3,076.60 was received from St. Louis County in Town Road Aid and \$9,927.00 from also from S.L.C. in 2018 Taconite Production Tax-2019 Distribution. Total February Disbursements: \$2,320.94. *Mitch accepted the report and Steve supported. Carried (3-0).*

### Approval to Pay March Bills:

Gibson, Sandra, \$14.13, Clerk Office Supplies

Lake Country Power, \$93.27, Electricity for Town Hall.

*Phil moved to approve payment of all bills listed on the agenda plus board payroll and PERA. Mitch supported. Carried (3-0).*

**Visitors Addressed:** Dean DeBeltz explained the wells which will be drilled on leased township property on Kaunonen Lake Road have not yet been drilled due to the extreme winter weather we've had and equipment break-down. Stainless steel piping will be used. He is hoping they will be done by early June. A question was asked about the use for these wells and Mr. DeBeltz explained that they are for water quality monitoring and will continue to be used for many years to come including during the operation of the mining, once all permits are secured. The use of these wells will be the largest hydrologic study done in the country.

**Road Report:** Township roads are frozen.

**Old Business:** At the February Regular Meeting, a motion was made and carried to invest the \$5,000 received from Twin Metals MN in a CD at the Members Cooperative Credit Union. However, when Bonnie contacted Members, she was told that in order to do that an active checking account would need to be opened. *The original motion was rescinded by Mitch. He then motioned to purchase a 1 year CD at Embarrass Vermilion Federal C.U. at a rate of .499% and was supported by Steve.*

Mail Ballot Voting has been researched by the Clerk and will bring her findings to the Annual Meeting on March 12. Sandy asked the St. Louis County Auditor's Office for clarification of how Mail Balloting would work if adopted by our township. Phil Chapman stated that the approximate cost for the county to administer mail balloting for both the Primary and General Election is \$500.00. Most of that expense is due to postage. Waasa's expense for both Primary and General was \$3,194.12. Ballots would be mailed out to each registered voter in the township 30-40 days in advance. The voter can vote at home at their leisure and has the option to use the postage paid envelope provided or turn it in to the County Auditor's Office in Duluth or Virginia.

The Clerk asked if anyone wanted to add anything to the Annual Meeting Agenda. Everyone agreed that a report from Twin Metals would be informative for the public. Mr. DeBeltz stated that he hoped that his manager of operations would be free to attend. Also, a representative from the Embarrass Region Fire Department would be more than welcome.

**New Business:** After review of the budget, *Mitch, with support from Steve, motioned set the recommended 2020 levy at the same amount as it has been for several years:*

General Fund:	\$15,000.00
Road & Bridge Fund:	\$8,000.00
Fire Fund:	\$11,000.00
<b>Total 2020 Levy:</b>	<b><u>\$34,000.00</u></b>

*Motion carried (3-0).*

Dave Hatfield of Davey Do Right Services was contacted for a price quote for doing lawn care at Amanda Cemetery for this season. There is no change in the charge. *Mitch motioned to continue using Dave Hatfield's service with support from Steve. Carried (3-0).*

The up-coming April 5 Spring Short Course was discussed. Bonnie, Sandy and Steve plan to attend. Newly elected officers (Steve) will be reimbursed by MATIT Agency for the registration cost.

Efforts to bring Broadband to St. Louis County are in motion. The Clerk will seek more information on this for the next regular meeting in April.

Classification of a 80 acre parcel to State Tax Forfeited Land was reviewed. No action was taken by the board.

Local Board of Appeal & Equalization for Waasa is *tentatively scheduled* for April 24 at 4-5 p.m.

**Correspondence:** All mail was read and filed, including a letter from Northwoods Partners asking for a donation. The Clerk will seek more info about the group and ask that a representative attend the Annual Meeting.

**Adjournment:** Mitch moved to close the meeting at 7:50 p.m. and was supported by Steve.

### Minutes

- **Building & Grounds Committee.** Rodney stated that a new lawn mower is needed. After membership discussion, it was decided that the Building/Grounds Committee should research and make a recommendation for a new mower including the cost.

### New Business

- The next Pancake Breakfast is May 4. Jerry said that Ducks Unlimited has rented the Timber Hall for May 4, following the Pancake Breakfast and that it will not interfere with the Pancake Breakfast. Sue said the Queens would like to have a Pancake Breakfast Fundraiser in June or July; the fundraiser was tentatively scheduled for July 13.
- **Standing Fair Committee Reports.**  
**Entertainment, Sound System.** Gus texted in names of bands that are booked so far. Sue will contact him about promoting the bands.  
**Miss Embarrass Region.** Bonnie can't attend Fair Board meetings so Sue will act as her liaison. The Queen float needs a spare tire, Floyd said he will take care of it. Sue stated that Bonnie requests a \$300 candy budget for the parades. It was decided the Financial Committee will look into paying for the candy. Sue said the Queens needs 10,000 raffle tickets. Terri said Bonnie should contact her for information regarding the online printing of raffle tickets.  
**Mud Run.** Floyd said Mud Run is on track.  
**Team Penning.** Doug explained that the belt buckle designs are ready and the cost of the buckles will be donated to the Fair. *Lisa moved that the Fair purchase the belt buckles with the understanding that the cost of the buckles will be donated to the Fair. Chris seconded. Motion carried.* Frank stated that Team Penning would like to purchase 13 additional panels so they won't need to be borrowed anymore. Jerry said to put the request on next month's agenda.  
**Classic Car & Truck Show.** Darwin requested \$400 for Car Show budget and asked that exhibitors be exempt from paying Fair admission. Lisa pointed out that everyone pays admission; volunteers, horse show participants etc. It was decided that exhibitors will continue to pay Fair admission. Darwin asked for 1,500 flyers and Dan suggested setting up bleachers for the Car Show, if space permitted.  
**Vendors.** Janine and Sue reported that they are receiving vendor agreements for both the grounds and Timber Hall.

### Miscellaneous

- Amber asked when the barn will be empty and Joe said it would be by the end of May. Amber requested new animal stalls for the barn. Jerry asked her to provide costs and fundraising information at the May meeting.

*Jerry moved to adjourn the meeting. Chris seconded. Motion carried.* Jerry adjourned the meeting at 8:15 pm.


