#### **Town of Embarrass Regular Board Meeting**

July 13, 2022 PENDING BOARD APPROVAL

Present: Jack LaMar, Alyssa Hammond, Mary Novak, Jennifer Boese

Meeting called to order by LaMar with The Pledge of Allegiance at 6:00 p.m.

Motion/ LaMar: Second/Hammond to approve June 2022 minutes. Carried 2-0.

Remaining ARPA Cares Act Grant and Tax Apportionment were deposited which will show in the July Treasurer's Report. Motion/Lamar: Second/ Hammond to approve Treasurers Report. Carried 2-0. Motion/Lamar: Second/Hammond to replace the funds transferred from Capitol Fund \$7,000 and Historical Fund \$8,000, both to be taken from General Fund once receipt for the Tax Apportionment is on record.

PUBLIC: Cemetery complaints about the mowing were expressed by public. Public feels that the cemetery should be higher on maintenance priority list. Hammond explains there were issues with a truck and a mower both being in for repairs which slowed things down, other properties need mowing as well. Hammond makes it clear that the cemetery is a priority and will continue to work on the cemetery with maintenance to make improvements. LaMar understands the publics concerns and says cemetery is of great importance and guarantees as a township supervisor to do what he can to make it better. LaMar also explains if seed and fertilizer were to be used to grow grass and not weeds as it mainly is now, then at the next annual meeting it needs to be budgeted for in the levy. LaMar also mentioned to the possibility of having some sort of volunteer plan set up to clean headstones and such.

Heritage Park and Campground Report given by Lori Worsham/Caretaker. Campground has been running smooth. Spraying for mosquitos has been done few times.

June Maintenance Report was given by Hammond. Continuous mowing of township properties. Town Hall outhouse repairs. Water barrel secured for Garden Club at the Info Center. Dragging of ball fields. Light replaced on flagpole at Nelimark Museum. General cleanup and maintenance duties.

Motion/Lamar: Second/Hammond to accept resignation of supervisor Gene Wright. LaMar points out that Wright was very knowledgeable and expressed his gratitude for all Wright has done with his time on the township board. Carried 2-0. LaMar acknowledges the interest by few individuals that are interested in filling Wright's term. Vote was taken. Motion/LaMar: Second/Hammond to appoint David Bialke as supervisor on the Embarrass Township Board. Carried 2-0. LaMar strongly encourages others interested to file for candidacy at the Clerk's office between August 1–16. Because all supervisors have been appointed; all three seats will be placed on the ballot. Two seats/ 2-year terms and one seat/ 4-year term.

Motion/Lamar: Second/Hammond to approve liquor sales at the Embarrass Regional Fair during the August 2022 fair. Carried 3-0.

Motion/LaMar: Second/Hammond to approve the Election Judge Resolution. Carried 3-0. Resolution signed.

Motion/LaMar: Second/Bialke to sign agreement and make payment to the Embarrass Regional Volunteer Fire Department. Carried 3-0.

Motion/LaMar: Second/Hammond to approve the resolutions presented by the Clerk to apply and for the township to accept grants or donations towards upgrades such as roofs on the Town Hall, Nelimark Museum, Campground upgrades, Signs around the township, including trails. Carried 3-0. Resolutions signed.

Motion/LaMar: Second/Hammond to remove Gene Wright on banking accounts, Embarrass Vermillion Credit Union and Northern State Bank and to add David Bialke to these accounts. Carried 2-0.

Supervisors go through first section of employee handbook and discuss changes and updating.

Establish priorities from the Property Inspection to be placed on the August Agenda.

LaMar spoke with township attorney on the Information Center Property after it was discovered it was incorrectly recorded with the county, LaMar was informed that indeed the Information Center Property belongs to the township.

July 21, 2022

Pending Approval

**Present Board:** Gustave Schroeder, Lisa Gibson, Jerry Meier, **Trustees**: Sue Beaton, Bonnie Meier, Janine Patten

**Members Present:** Roland Fowler, Jim & Jo Hardy, Tana & Mike Johnson, Floyd Joki, Sherie Joki, Shireen Lee, Douglas Mattson, Bonnie & Jerry Meier.

**Call to Order.** Gus called the meeting to order at 6:32 pm.

**Minutes:** The minutes of the June 21 meeting were distributed for review. No changes. *Charlie moved to accept. Jo seconded. Motion carried.* 

Treasurer Report: The reconciled financial report ending June 30, 2022, was reviewed. Jerry noted the purchase of a new lawnmower and the cattle chute as recent expenses (roughly \$5,500 combined). He also stated that we received a \$750 grant from Lake Country Power; these funds will be put toward the purchase of a tent and tent canopy (replacing the one destroyed by wind in 2021). Jerry clarified that as a 501c3 (Federal) entity, the ERFA does not pay income tax, however, we do pay sales tax on purchases. Lisa motioned to accept the treasurer's report. Mike seconded. Motion carried.

#### **Old Business**

- Status of Grant /Bids (Gus/Jerry/Tana).
  - Tana acknowledged the Lake Country Power grant and stated that the AEOA (BER) grant is on hold. (Thank you to be sent)
  - Tana is continuing Grant training through the Minnesota Council for Nonprofits. To date she has completed 2 of 3 training sessions.
  - Tana continues to research potential grants and obtain quotes for identified projects. She reiterated the importance of tracking volunteer hours so that we can apply for in-kind matching funds grants. Event chairs need to help ensure that all volunteers before and during the fair track their hours (online and paper tracking sheets are available; submit to Tana monthly).
- Maintenance Priorities (Gus/Jerry/Tana).
  - Tana reported that as part of long-term strategic planning for the ERFA, a Strategic Planning Subcommittee has formed. (See New Business)
  - A new water line is being added on the arena side of the grounds. Floyd will be working on the week of July 24 and it will be operating in time for the Fair
  - Electricity for the arena side of the grounds is on the strategic planning list.
  - Jerry reported that Rodney has the materials for the outdoor benches

- The lawnmower has been purchased.
- Neither the Secretary nor Web Design volunteer positions have been filled. For the time being, members are asked to fill in as necessary.
- <u>Kitchen Rental during Fair.</u> Sue reported that the kitchen will be open Saturday and Sunday and serving breakfast from roughly 8 until 11:00 am and switching to walking tacos for the afternoon.
- <u>Timber Hall Rental update</u> (Jerry/Bonnie). Jerry reported that the number of rentals this summer/fall are behind last year at this time.

#### **New Business:**

- STATEGIC PLAN: A subcommittee is developing a strategic plan that will be introduced and discussed on Monday, August 1, at 5:30 p.m. at Timber Hall. All interested community members are welcome. A strategic plan is necessary to guide the organization into the future as well as include when applying for grants.
  - Shireen/Tana stated that the office is in need of a portable laptop, Windows 365, general office supplies, printer/scanner, etc. Shireen moved that the ERFA provide up to \$1000 to fund upgrading the office. Mike seconded. The motion carried. Following the vote, Shireen requested approval to create notecards and stationery that reflect "the Fair" and separate stationery for "the Timber Hall." Using existing logos, she will bring designs to the next meeting.
  - Shireen also suggested that since we do not yet have a web site, we could work with the Township at "embarrass.org" to house updated Fair information. She will check into it.

#### Team Penning (August 19-21)

 Doug stated that Team Penning and the Ride, Raffle 'n Roll for ALS are set to go and that Beef and Pork raffle tickets are selling extremely well.

#### FAIR Business (August 26-28)

- <u>Fairbook.</u> Jerry that Fairbook are being distributed all over the area and asked everyone to meet him after the meeting to take the remainder and help distribute.
- <u>Tents.</u> Jerry and Gus will order the replacement canopy for last year's tent. Lisa moved that we buy an upgraded 40 x 20 tent (approx. \$1200); Jo seconded. Motion carried.

#### • Event Updates:

All event chairs present stated that they are ready for the Fair with the following caveats:

 Animal Barn. At present, we do not have a veterinarian on site. Animals on display will therefore need to have their owner present at all

- times. Amber will display her animals and will contact potential exhibitors with this sad news.
- <u>Exhibit Building</u>. Amber will be coordinating entries in the Exhibit Building!
- Horse Show/Team Penning. Doug stated that a drag is needed for the arena. Doug moved that a 6 ft drag be purchased not to exceed \$400. Seconded by Jo. Motion carried.
- Grounds. Charlie stated that he has mowers and spray set to prepare the grounds and volunteers to help out at the gates.
- Outdoor concessions. Sue reported that she has arranged for The Forge Social Haus Mobile Axe Trailer to be at the Fair on Saturday pending approval. Doug moved that we approve the Axe Trailer and modify the hours to 11 am to 7 pm. Tana seconded. Motion carried. Sue also reported that she continues to pursue other outdoor concessions.
- Parade. YES! There will be a parade! To ensure the safety of parade participants, Gus will coordinate getting signs to that warn drivers to Slow Down, Parade Ahead, Be Prepared to Stop, etc.
- Instructions for Gate Volunteers. Janine will draft the Do's and Don'ts of selling wristbands at the Gate.
- Free fair admission for volunteers. Event chairs should list their volunteers and report the number of wristbands they need to Jerry at the next meeting. Volunteers must have their wristbands to be admitted at no charge.

#### Miscellaneous

The former Queen Trailer and old lawnmower are no longer functioning. The Fair Board agreed to donate both to Floyd free of charge (valued at \$200).

Shireen suggested that a Volunteer Appreciation Event be considered for some time in September or October. Anyone interested in help to coordinate such an event should contact Shireen.

Doug made a motion to adjourn. Lisa seconded. Motion carried. Gus adjourned the meeting at 8:37 p.m.






