Board Meeting

PENDING BOARD APPROVAL

Present: Bernie Mettler, Roy Worsham, Mary Novak, Jennifer Boese

Visitors: Cindy Koivisto, Dick Tornow, Mickey White, Jack LaMar, Bill Wright, Gene Wright

The meeting was called to order by Bernie Mettler at 6:00 p.m. with The Pledge of Allegiance.

Motion by Bernie to accept the July 11, 2018 minutes with few corrections to spelling and brushing was done by the State not the County. Second by Roy. Carried 2-0.

Motion by Bernie to accept the Treasurers Report. Second by Roy. Carried 2-0.

Campground Report was given by Cindy Koivisto. Campground has been sprayed for mosquitos. She asks that it is sprayed one more time before the Embarrass Fair. The weekend of the Fair the campground is full except for one tent site, and have an ATV club coming and have booked most sites. Construction workers have been keeping the campground pretty full. Cindy gives the board her letter of resignation. The board thanks Cindy for everything she has done and says she will be missed and hard to replace. Dick states he will be leaving out of the campground on August 29 and says he would like to come back next year if the board approves.

Road Report was given by Roy. Roads have had gravel placed and graded. Culvert on Sauna Road was replaced. Somehow a miscommunication about the Info Center not getting graded.

Maintenance Report was given by Roy. Mowing of properties. Mid-season maintenance on mowers. Town Hall steps painted. Driveway at Nelimark brushed and limbed. Dead Jack Pine at Nelimark removed. Town Hall basketball backboard removed and refurbished. Walking trails at Heritage Park cleared and dragged. Assist Chris Alaspa mounting signs at ball fields. Started dragging rink in preparation for ice. Horse shoe pits installed at campground. Rotted timbers at Info Center entry work done. Majority of damage caused by insects.

Exterminator has been called. Interior of warming shack has been painted. Husqvarna to Grande's for repairs. Regular maintenance duties. In maintenance notes written by Roger he suggests that the lease for the container site from the town should be negotiated. We receive \$300.00 per annum and spend about \$240.00 for dump card. Board thinks that would be a good idea.

Post Office Report was given by Bernie. Holding tank has had no problems since repaired. The USPS will be building a ramp at the back entrance for the carriers and delivery drivers, for safety reasons, per USPS. Clerk to call USPS about handicap signs. Parking lot was paved.

New Business Clerk asking for more brochures because they are running low. Visitors pointed out few items in brochures that are no longer accurate. Board says to hold off on brochures at the moment. In the off season possibly get them upgraded.

Question was asked if the rent money from Post Office was going back into reserves. Bernie responded with it is going back into the Post Office funds account at this time. Money in the account is needed right now to pay the paving invoice and some money will have to be kept into the account for any emergency or repairs for the Post Office but money will be put back into the reserves once this is complete.

Switching from the Northern State Bank to the Embarrass Vermilion Federal Credit Union was discussed and some are unsure of switch. *Motion by Bernie to rescind the motion of switching accounts from Northern State Bank to EVFCU. Second by Roy. Carried 2-0. Motion hold off on switching of banks until we can make a better decision. Second by Roy. Carried 2-0. Motion by Bernie to take Sandra Gibson off of checking and savings accounts at Northern State Bank and EVFCU. Second by Roy. Carried 2-0. Maturity dates on the CD's will be corrected on the cash control sheet.*

Old Business Purchasing of a new lawnmower was discussed by the board after looking at the quotes that Zane received. *Motion by Bernie to wait until spring to purchase a lawnmower. Second by Roy. Carried 2-0. Residents recommend an industrial zero turn when the topic comes up again in the spring.*

The test requested for the gravel was received by Wingers and passed 100%.

Claims & Correspondence *Motion by Bernie to accept the Claims & Correspondence. Claim #'s 16882 – 16915 (\$7,683.37). Second by Roy. Carried 2-0.*

Meeting adjourned by Bernie at 7:07 p.m.

The Treasurer's report was accepted as read on a motion by Rasmusson/Langowski 3-0.

Claim forms 2175-2186 were accepted by Langowski/Johnson 3-0.

OLD BUSINESS:

Ashley Backman will take care of cleaning town hall.

Leseman Rd will be flagged 18 ft off center for clearing right of way.

Supervisor Langowski will order the minimum maintenance signs needed on a motion by Langowski/Rasmusson 3-0.

Meeting was called to order at 7:00 p.m. by Board Chair Mitch Lind and the Pledge of Allegiance followed.

Minutes Approval: *Emily moved to approve the June 5, 2018 Regular Meeting Minutes. Mitch supported. Carried (3-0).*

Treasurer's Report: Receipts: Embarrass Vermilion Fed. Credit Union Quarterly Interest: \$57.42 and St. Louis County (Tax Apportionment 5/18) \$22,021.67. Total Disbursements from June 2018 Regular Meeting: \$2,900.88. *Emily accepted the report and Phil supported. Carried (3-0).*

Approval to Pay Bills: *Emily moved to approve payment of the bills listed below and payroll with support from Mitch. Carried (3-0).*

Road Report: Phil will be checking all township roads soon. After the recent storms, he may need to apply some gravel.

Since the signage must be installed under legal regulated measurements, a contractor has been sought. After many phone calls and emails, only one contractor has responded with an estimate. John Petersen of Sign Solutions gave us a quote of \$2,653.99. Clerk's Note: Since this is over the authorized price range decided at the June meeting, Sign Solutions was not given the ok yet. *Emily motioned to hire Sign Solutions to install the "Road Closed" signage on South Skarp Road. Mitch supported. Carried (3-0).*

Cemetery: Dave Hatfield, from our new lawn service, asked if we want him to mow in and around the trees that were planted on the west side of the old section of the Amanda Cemetery. The board didn't feel it was necessary to keep it mowed since the trees have grown up nicely and are healthy.

Last month Pearl Alaspa was buried and on July 13, Dion LaSart's cremains will be entered. Both families had purchased lots earlier.

Old Business: The Clerk checked on procedures on ordinance writing and what needed to be included in it for the problem we have with dumping of raw sewage in the township. An email response from MN Association of Townships Attorney Steve Fenske indicated that we should take a different approach and get the proper authorities to work on the problem. MN Statute 609.671 may be applied in this case but we need the sheriff and county attorney to decide if it is correct. Emily volunteered to make calls to find out if there are permits on file for the property owner and if fines are in order. The ordinance has been put on hold for now.

New Business: The list of Election Judges for 2018 elections was approved on a motion by Phil and supported by Emily. *Carried (3-0).* List is as follows: Lois Asleson, Kim Daugherty, Lorenda Daugherty, Arlene Eckman, Bonnie Keller, Linda Koskela, Meghan Martin, Emily Quick (Alternate) and Julie Shere

Election by mailed ballot only was discussed by the board. Sandra learned at Clerk's training that several townships already have gone to this type of voting. Instead of holding elections at our own town hall, we would be sent a ballot from St. Louis County (free of charge). After voting the ballot would be mailed back to the county. This would eliminate the need to hire local election judges, the cost of their training, the cost of up-keep of the AutoMark machine and other misc. costs that

come with an election. Waasa would be eligible to use this option since we are under a population of 400. The board decided to table this issue but would to bring it to the citizens of Waasa to decide at the 2019 Annual Meeting. If the people agree to it, the board would the make a resolution supporting it.

Phil plans to attend the St. Louis County meeting in Ely on drafting of a new Land Use Plan on July 17 starting at 4 p.m.

Mitch and Sandra attended the Summer Short Course at the DECC on June 28. Mitch received his certification for Board of Appeal & Equalization there. Sandra will be attending more Election Training (called Train-the-Trainer) on July 18 at Clinton Township.

Filing period for Township positions starts July 31 and ends August 14 at 5 p.m. (2) Supervisors and (1) Clerk seat will be open. The Clerk will be seeking a couple of new people to work the elections. Training for election judges will be held the week of July 23.

Paul McDonald and Bernie Mettler, candidates for County Commissioner, will be attending our August 7 meeting. Emily posted on FB that any other candidates are welcome to join in on a little debate. Emily and Sandra will come up with a list of questions for them.

Correspondence: All mail was read and filed.

Adjournment: *Emily moved to close the meeting at 7:55 p.m. and was supported by Phil. Carried (3-0).*




