Regular Board Meeting  
September 12, 2018

### PENDING BOARD APPROVAL

Present: Bernie Mettler, Zane Beaton, Roy Worsham, Mary Novak, Jennifer Boese

Visitors: Kirk Saranpaa, Jason & Dianna Ferrell, Cindy Koivisto, Bob Scherer

The meeting was called to order by Bernie Mettler at 6:01 p.m. with The Pledge of Allegiance.

*Motion by Zane to accept the treasurer's report. Second by Bernie. Carried 3-0.*

Jason and Dianna Ferrell ask the board if chloride will be put on Hanka Nevala Road. Roy explains to the residents that the ATV club would be doing the chloride. Ferrell's spoke with Gene Wright and were told to come to meeting to speak with board not ATV club. It was believed by Roy that the ATV club would be paying for the chloride on the road being that it was part of the ATV trail. Next year some of the township roads may be sprayed with chloride if the funds are available. A question about plowing of snow was asked. Hanka Nevala Road and why it doesn't get plowed in the mornings. Roy explains that the county plows the main roads first and must do so according to the county regulations. The gravel roads are done after all the blacktop roads are complete. (Later Gene Wright arrived at meeting and spoke with Roy about the chloride.)

**Road Report** was given by Roy. Information Center was graded. A culvert on Laitinen Road gave way and created a hole on the road that is currently being repaired. The rest of the roads are looking pretty good.

**Maintenance Report** was given by Zane. Continuing mowing of properties. Walking trails at Heritage Park dragged several times. Doors on outhouses at info center repaired and painted. Range

Pest Control treated Info buildings for powder post beetles and will need to be treated again next June. Tree thinning and removal at Info Center and Skating Rink and Campground. Campground shower house washed and coat of sealer applied. New platform built to replace rotted one at the Skating Rink Warming Shack. Skating Rink walls straightened and reinforced. New locks installed on Garage and Storage Shed by Biss. Crews assigned to Fair Board for set up and break down of Embarrass Fair. Large trailer had repairs and replacement of broken items completed to lighting system. John Deere mower deck in need of weld job. Maintenance asking if equipment that isn't used to be put up for bids. *Motion by Bernie to put Cement mixer and DR string trimmer up for bids. Bids to be in by October 10 at 4:00 p.m. Second by Zane. Carried 3-0. Motion by Bernie to get deck welded on John Deer before winter. Zane to contact welder. Second by Zane. Carried 3-0.*

**Campground Report** was given by Cindy Koivisto. Campground shower house walls were given one coat of stain and will be given another. Mosquito spray worked well for the Embarrass Fair weekend. Cindy is planning on leaving the October 5. The board again thanks Cindy for the fantastic job of being the Heritage Park Campground Caretaker. Board would like Roger to determine per weather when water should be shut off at campground. Clerk is to advertise for a campground caretaker.

#### **New Business:**

Mike and Deb Minier did not come to meeting as on agenda, they informed clerk that they spoke with township sexton about the plot issue they were having.

Cemetery Deed was signed by the board and clerk.

Copy of Insurance Contract for Post Office was given to the board to look over and will be approved or changes will be made at next meeting in October.

Kirk Saranpaa is concerned about a piece of property he owns that is in tax forfeit. Wanted to know if the Township wants the property. Board ask the clerk to contact the county about the property.

Township maintenance, Roger is concerned about headstones at the cemetery that are tipping and could possibly fall and injure someone. Board wants the clerk to try and notify families, being it is their responsibility to fix.
