Special Board Meeting September 7, 2022 PENDING BOARD APPROVAL

Present: Jack LaMar, Alyssa Hammond, Dave Bialke, Jennifer Boese

Visitors: Gene Wright, Tom Hammond, Isaiah Hammond

Meeting was called to order at 6:00 p.m. by LaMar with the Pledge of Allegiance. LaMar informs those present the reason for the meeting is to address the needs for maintenance and the issues at hand regarding maintenance. LaMar gives Maintenance Supervisor Hammond the floor. Hammond discussed the reasons she was given by maintenance for resigning. Hammond has been reaching out to maintenance to check work status and see what should be prioritized. Currently the township has summer hire, Lisa Gibson as the only maintenance employee until lead maintenance returns. Hammond has prioritized the Cemetery, Town Hall, and Campground to be moved along with restroom cleaning, garbage pick-up and added winterizing the campground when season is over. Clerk to check with lead maintenance to get the instruction guide for winterizing the campground. LaMar states he will do the winterizing of the campground. Summer hire will be starting new employment but has offered to come in on some weekends for a few hours, board approved during August meeting for Gibson to work until end of December. (Clerk notes: Gibson left keys with clerk on 9-15 at end of workday, stating she feels there is enough help from clerk and supervisors to do the maintenance work that needs to be done, she feels she is no longer needed, very thankful to the clerk and supervisors for everything and enjoyed her time working for the township. Currently Clerk has been cleaning town hall inside and the outside entrance area. Clerks husband has been picking up garbage from Town Hall, Information Center and Campground and has brought to dump station. Clerk along with Bonnie Davies have been cleaning and stocking restrooms at Information Center) LaMar states going forward need to have leadership and communication improvements as well as safety being important, communication is a big part of that. The board will work with maintenance to provide a better work environment. needs to be protected and given the resources to be able to do their job. Part of that is feedback from maintenance to the supervisors. Wright tells the supervisors that Gibson needs to be paid for being the only maintenance employee at this time and should be retro paid. LaMar agrees Gibson has stepped up immensely and feels an increase in wage should be given, all supervisors agree, Motion/Hammond: to increase the wage of summer hire, Lisa Gibson. Second/LaMar. Discussion had. Motion continues; retroactive Gibson's wage to regular maintenance wage starting July 18 when lead maintenance went out for surgery then starting August 30 to receive lead maintenance. Carried 3-0. Maintenance wages were discussed, and supervisors feel maintenance wages should be adjusted. Discussion was had. Motion/LaMar: Second/Hammond to post and file for a Town Meeting, September 28 at 6 p.m., business/agenda to increase the salary for maintenance and ask town to adjust the levy for 2023. Carried 3-0. With being shorthanded temporarily with maintenance employees the board signs resolutions of conflict (C6000/Appendix B: Minn. Stat 471.88, subd.5) to step in when needed for township maintenance duties as paid employees. Resolutions signed. Motion/Lamar: Second/Hammond. Carried 3-0. Motion/LaMar: Second/Hammond to post for maintenance position opening, ending on the September 22. Carried 3-0.

Meeting adjourned at 8:21 p.m. by LaMar.

LaMar calls the meeting to order with The Pledge of Allegiance at 6:01 p.m.

Motion/LaMar: Second/Hammond to approve the August 10, 2022 minutes. Carried 3-0.

Motion/Hammond: Second/LaMar to take \$3,000 from EVFCU savings account that was a donation towards the Information Center Restroom Project and move it to the Local Grants account. Carried 3-0. Motion rescinded and corrected the amount to \$2000. Question was asked on the \$6,113.67 receipt from EVFCU savings that was deposited into the local grants fund in July of 2021. A \$12,000 donation from St. Louis County was received. An invoice for prep work was paid with part of the donation. The remaining \$6,113.67 went into savings until it was needed towards another invoice for the project, which in July of 2021 the money was then transferred to Local Funds after the Local Grant Fund was opened and invoices due for payment were then paid. Second/LaMar to put \$1110.00 from the Post Office Rental Payment into savings each month and the remaining \$100 into the Post Office Fund. Carried 3-0. Boese and Novak encourage supervisors to meet with them when there is time to look and learn the State Auditors CTAS program Boese and Novak work with to better understand where funds, claims, disbursements, receipts and reports are kept. Supervisors agree.

Maintenance Report was given by Hammond. Information Center restroom floors were painted with grip paint. One solar light was replaced waiting on other repair kit. Lead maintenance out on medical leave, second maintenance turned in resignation. Summer hire will be starting new job but will stay on for weekends to help. Job posting was posted, few applicants have applied, deadline is September 22 to have applications in. Pyhala hayfield was mowed by Gus Schroeder.

Bialke gives road report and explained work that should be done on township roads. Clerk to type Baalke's scope of work report and supervisors will be discussed later posting for bids on the work needed.

Caretaker Lori Worsham gives the Heritage Park Campground report. Campground has been full and running smoothly. Most sites are full till the closing date. Discussion was had on the overflow area for campers during the fair weekend and the amount to charge and how to set the area up. To be discussed next season to make the final decision. Motion/LaMar: Second/Bialke to offer a 25% discount across the board at the Heritage Park Campground after October 1st, Carried 3-0. Motion/LaMar: Second/Hammond to rehire Worsham's for season 2023 as Heritage Park and Campground Caretakers. Carried 3-0. Worsham's are

thanked by all for the great service and dedication to the campground.

Cemetery Deeds approved and signed by the board.

Supervisors discuss updates for the Employee Handbook.

Motion/Hammond: Second/Bialke to approve the Claims and Correspondence. Carried 3-0.

Motion/ LaMar: Second/Hammond to approve the Audit completed by the supervisors. All claims and funds found accurate and in order. Carried 3-0.

LaMar adjourns meeting at 8:47 p.m.

Minutes Approval: Steve moved to approve the July 6, 2022 Regular Meeting minutes. Mike supported. Carried (3-0).

ERFA Organization Planning Meeting Minutes September 15, 2022 - 5:30 pm Pending Approval

**Call to Order.** Gus called the meeting to order at 5:33 pm and reminded everyone that this meeting is an organizational meeting and the Fair meeting will commence at approximately 6:30 pm. He then asked that we introduce ourselves as there were several new faces around the tables.

**Minutes:** The minutes of the August 18 Organization Planning Meeting combined with the ERFA Meeting minutes of the same date were available for review. No changes. *Shireen moved to accept. Sue seconded. Motion carried.* The minutes of the September 8 Organization Planning Meeting were available for review. *Tana moved to accept. Shireen seconded. Motion carried.* 

Treasurer Report: Jerry provided a Summary of the Year-to-Date account balances in a new format by budget category and stated that this will help us to budget for next year's fair. Income from the fair is positive \$3,610.02. Anticipated income will increase with the pancake breakfasts and storage building rentals. Anticipated expenses include sales tax and propane. The increase to \$5 gate fee helped enormously. Sue stated that attendance was approximately 4,100 paid adults. Detailed breakdown provided in the Fair portion of the meeting.

Janine pointed out that Thank You notes are due to the Embarrass Region Fire Department for their volunteer participation and the Tower Fire Department for financial contributions in July and August.

Shireen moved to accept the Treasurer's report. Janine seconded. Motion carried.

#### **Old Business**

- Volunteer Appreciation Event, October 15, 4:30 pm (Shireen)—tabled for Fair meeting to approved budget.
- <u>Leak from metal roof above kitchen</u>. William Ramponi replaced the piping and added a snow slide. He and Gus agree that this may do the trick. William donated his time and materials. Huge Thank YOU to William.
- <u>Candidates</u> for membership and board positions. According to our bylaws, officer nominations are to be presented at our January 19 meeting with a vote at our February 16 meeting.

#### **New Organizational Business**

- Committee Proposals. (Tana & Paul) As part of the reorganization effort Tana requested approval from the board to permit the formation of a planning committee. The Planning Committee can be expected to advise the board on governance structure, submitting recommendations to the board for their approval. Clarification of roles, responsibilities, and expectations will benefit the health of the board and help for future grant applications. Paul moved that the board approve the formation of a Planning Committee. Janine seconded. The Planning Committee will meet at the Timber Hall on Thursday, September 29, at 5:30 pm.
- Energy Expenditure Proposal (Tana). We have been awarded up to a \$20,000 grant from AEOA to cover 1/3 of the cost to address specific energy improvements to Timber Hall. Tana explained items on our project list that fall under energy improvements include replacing doors, insulation, chinking and replacing and restoring rotting and damaged logs. Funding from other sources will be necessary to meet the remaining two thirds. Tana moved for a resolution to apply for grants from St. Louis County, IRRRB, and Northland Foundation be approved. Chrissy seconded. Motion passed. Tana additionally mentioned a list of potential sources that she could apply for grants to be included in the minutes pending submission.
- CDBG Application. (Tana) Tana explained the CDBG grant is only applicable to us for ADA needs because the median income in our area is not considered low to moderate as determined by official governmental sources. There is a difference between ADA Compliant and Handicapped Accessible. Tana will be looking at the CDBG grant in terms of replacing the non ADA compliant doors (a high priority). The deadline for this application is October 15.
- <u>Commitment of funds for CDBG application</u>. (Tana) Not required at this time.

- Fundraising Events (Shireen)
  - Bingo/raffle status. Sue and Shireen will research further to determine if this is a viable offering for us.
  - Coffee at Hall. Shireen suggested that providing a space for community members to meet for coffee would be a viable use for Timber Hall. Others mentioned that the Town Hall is staffed and already provides that space. Heating and staffing are a concern. Tabled.
  - Spaghetti Dinner. Shireen stated that she know a few people who are certified ServSafe and could potentially serve as our "certified food protection manager."
    - POST MEETING NOTE FROM SUE: If we want to cook and serve more often, we should upgrade our license with the Dept of Health to a Seasonal Permanent Food Stand License. The cost is \$290/year and gives us 21 days per calendar year. (This would replace our current Special Event Food Stand License which covers our pancake breakfasts plus two days and does not require a ServSafe kitchen manager. Our current license is \$95 annually)

**POST MEETING NOTE FROM TANA:** No future organization meetings will be taking place at this time. The planning committee will meet 9/29 at 5:30 pm. at the Timber Hall. If interested in being a part of the planning committee, contact Tana Johnson at 218-269-1331.

Call to Order. Gus called the meeting to order at 6:43 pm.

Minutes of the July 21 and August 18 meeting were approved at the earlier meeting.

Treasurer Report. Jerry provided a Summary of the Year-to-Date account balances in a new format by budget category and stated that this will help us to budget for next year's fair. Income from the fair is positive \$3,610.02. Anticipated income will increase with the pancake breakfasts and storage building rentals. Anticipated expenses include sales tax and propane. The increase to \$5 gate fee helped enormously. Sue stated that attendance was approximately 4,100 paid adults.

Fair Attendance: Sue summarized the attendance based on wristband sales and stated that the number of wristbands sold at the north gate was slightly higher than the south gate for the total weekend.

Friday, 100 Daily bands were sold; 320 Weekend bands were sold

Saturday, 1,449 Daily bands were sold

Sunday, 1,257 Daily bands were sold

If we assume that everyone who bought a weekend band also attended Saturday and Sunday, the overall paid attendance was 4,166. Keep in mind that children 10 and under do not pay and volunteers and vendors are not charged for wristbands. Estimates indicate that this compares favorably with past years and future Fair attendance will be recorded so that we more readily compare from year to year.

Team Penning (August 19-21)

- Paul noted that income from Team Penning was lower than expected because of a few factors:
  - The number of teams competing was reduced from 110 teams last year to 82 teams this year.
  - One cow went missing at the start and consequently had to be paid for.
- The weekend was well attended.

Fair Feedback (August 26-28)

The focus of this meeting was feedback about the Fair. Detailed notes will be available at the October 20 meeting. Several ideas for changes and improvements were mentioned and documented for use as we look forward to our 2023 Fair on August 25-27.

Volunteer Appreciation Event — Shireen stated that the event scheduled for October 15 at 4:30 pm, Timber Hall, will include pizza, salad, beverage; a program listing honorees will be assembled; and she has lined up two speakers. The current estimate it 133 attendees and Fair leads are asked to invite the folks that volunteered with them during the Fair. Shireen moved that a ceiling of \$1500 be budgeted to cover the expense for food and dining supplies. Jerry seconded. Motion passed.

Pancake Breakfast: Saturday, October 1

- Advertising—Sue will contact the East Range Times and TimberJay. Gus will set out signs the week of September 26.
- Volunteers—Volunteers are needed. Please contact Jerry and Bonnie Meier if you are able to help.

#### Miscellaneous

Holly raised a concern about the two-meeting format. She felt that the minutes of the Fair meeting and the Treasurer's Report should be reviewed and approved at the Fair portion of the meeting and that she is confused by the 5:30 meeting and what control they have over the Fair board.

Tana stated that we are in a transition time that is kind of confusing for everyone (and several agreed). Tana explained that the goal of the organization meeting is to create a structure of the organization so that we can better function as a non-profit business. There is obvious overlap and we are still trying to figure out approaches to improve the health of the nonprofit business, and grow the vital activities and events that take place on the property such as the annual fair. Tana apologized for the confusion, thanked people for their honest input, and suggested that in the future, the traditional monthly meeting should continue but to include agenda items specific to the management of the organization in addition to items related to fair activities. Tana stressed that the nonprofit business is a business; the fair is an event, and that it is important the business is managed as well as events.

Gus emphasized that the Timber Hall and property are 30 years old and in need in of attention. Many members are invested in the Fair and ensuring the Fair happens every year and others are wanting to ensure that the Timber Hall is maintained, electric and heating bills paid, and revenue sources are found to improve and maintain the property.

This would also encompass promoting Timber Hall as an Event Center year round with the idea that the annual Fair is just one of many events sponsored at Timber Hall. Both approaches are imperative to ensure the continued existence of both the Timber Hall and the events held on the property. People are the greatest asset, and it is imperative everyone knows that whatever role they are interested in, their support is wanted and needed.

All agreed that we are in a state of change and flux and moving forward is different and often confusing. It was agreed that the traditional monthly meetings would continue with the inclusion of organizational agenda items. It was also decided that the previously noted "Organization Meeting" would no longer be held at this time and that a Planning Committee would meet on Thursday, September 29, at 5:30 pm.
