Town of Embarrass Regular Board Meeting October 11, 2017

PENDING BOARD APPROVAL

Present: Zane Beaton, Roy Worsham, Jennifer Boese

Visitors: Kirk Saranpaa, Cassandra Hainey, Paul Knuti, Patricia Palo, Phyllis Constant, Carl Baranzelli, Amanda Nelson, Cindy Koivisto

The meeting was called to order at 6:02 by Zane Beaton with The Pledge of Allegiance.

Motion by Zane to approve the September minutes. Second by Roy. Carried 2-0.

Motion by Zane to approve the Treasure's Report, pending Audit. Second by Roy. Carried 2-0.

Campground Report was given by Caretaker. Caretaker to be leaving for the season. Camping Patron is still at the campground for few more days. Maintenance to shut off water for the winter.

Maintenance Report was given by Roy. Brush mowing the Pyhala. Painting at Weather Station. Ramp for the shed at the Town Hall was built. Damaged benches along the bike path repaired. Trees were removed on several roadways, cemetery roadway and bike trail. Trailers were repaired by Auto's Repair. Larger trailer needs new tires. Office door was replaced and a complaint was sent to Menards because casing was broken, not milled for lock and the trim was not installed properly. Request for replacement door was sent by Roger and Clerk. Brushing on the bike path has started. Final mowing of properties in progress. Ice Candles markers being put out as orders are coming in. Regular maintenance duties throughout the month completed.

Road Report was given by Dennis. Roads are in pretty good shape. Covered with needles and leaves at this time of year. The grader is now parked at the Town Hall for the winter. The Info Center was graded, it has been holding water because of the spring that is there. Blade may need to be replaced on the grader next season. Dennis suggests that the grass along the roads be cut.

New Business:

Roy motions to approve Gary Rantala to make signs along the walking trail naming some of the trees. Second by Zane. Carried 2-0.

Amanda Nelson tells the board about herself and offers her services as a grant writer. She would like to talk with the community and come back in a month to get public input. Amanda has spoken with IRRRB and there is money to expand opportunities. Board asks Clerk to help Amanda get in contact with Chris Alaspa.

Cassandra Hainey tells the board about herself. She has spoken with Roy in the past about foundation and restoration and what types of funds are available. Cassandra hands the board a resolution to make application and accept funds from IRRRB along with a scope of work and CDBG focus areas. *Roy motions to hire Cassandra as a grant writer at \$50 per hour/ 35 hour per year. Second by Zane. Carried 2-0.* Zane suggests Cassandra get the pre-application done and get in contact with the clerk to get the boards contact information. Roy gives Cassandra all the bids he has received. Board looks over resolution. *Motion by Zane to accept resolution. Second by Roy. Carried 2-0. Resolution signed.*

Land owners discuss with the board the issue they are having. Roy points out to Dennis and Phyllis Constant that this is done and the township isn't responsible to pay for a survey if the logger went off it is not our fault. Witness posts used to be on the property by the bridge but it is believed that were taken out by the loggers or the bridge workers. Board suggests that they call the logger and Tom Rukavina to see if he is able to help them with the post being removed. Roy also gives the Constant's a name of a St. Louis County employee to get ahold of from Duluth. Kirk Saranpaa points out that the Township gave him an easement years ago to allow Kirk to get to his property.

Bids were opened by the board. *Roy motions to accept furnace bid of \$140.00. Second by Zane. Carried 2-0.* *Roy motions to accept bid for Cub Cadet Lawnmower for \$125.00. Second by Zane. Carried 2-0.* Maintenance to remove furnace on Monday. Board agrees to remove the

air conditioner at the same time and put it up for bids again.

Old Business:

Clerk is still waiting for quotes on furnace and air conditioning units. Clerk will be contacting more companies to ask for quotes. (Clerk has called and sent information for quotes to six companies). Clerk has been in contact with USPS Project Manager. He is looking for updates and dates on when building will be moved. Building will be moved when the weather allows. The wet grounds have caused delays. Clerk informs the board that Todd Saterbak (USPS Project Manager) will be here Thursday the 19th at 1:00 along with 6-10 construction employees with the USPS to discuss the pre-construction. They wanted to meet at the Post Office building but being that the building is not at the site they are meeting at Town Hall. Todd would like the board to come if possible. Clerk has since posted the meeting and informed Tower Postmaster.

Motion by Zane to approve correspondence and claims 16611-16636 (\$9,091.51), Payroll (\$4,797.47). Second by Roy. Carried 2-0.

Meeting adjourned at 7:26 pm.

Regular Board Meeting
Tuesday, September 5, 2017, 7:00 p.m.

Board Members Present: Mitch Lind, Emily Quick, Phil Hebl, Bonnie Keller and Sandra Gibson

Visitors: Creighton Cox, Floyd Joki, David Hess, Linda Koskela and Kevin Kappes

Meeting was called to order at 7:00 p.m. by Board Chair Mitch Lind and the Pledge of Allegiance followed.

Minutes Approval: Mitch moved to approve the August 8, 2017 Regular Meeting Minutes. Emily supported. Carried (3-0). Minutes from the Special Board Meeting held on August 22, 2017 were approved by Mitch & supported by Phil. Carried (3-0).

Treasurer's Report from August Meeting: Receipts: \$8,953.00 from State of MN (2016 Taconite Production Tax) and \$811.69 from State of MN (2017 MN DNR PILT). Total disbursements were \$31,898.33. Mitch accepted the report and Phil supported. Carried (3-0).

Approval to Pay Bills: Emily moved to approve payment of all bills listed below & on the agenda with support from Mitch. Carried (3-0).

Babbitt Weekly News \$32.00, Special Town Meeting Ad Blomberg & Sons \$13.02, Gas for Mowing T. Hall Gibson, Sandra \$25.00, Reimb. For County Plat Book Lake Country Power \$93.00, Electricity for Town Hall Lakes Gas Co. #45 \$343.66, Heating Propane for Town Hall

Emily motioned to have Operation Round Up taken off our Lake Country Power bills from now on. Mitch supported. Carried (3-0).

Visitors Addressed: Floyd asked the board's permission to do some brushing on the back side of the lower section of the cemetery. This offer was met with approval since this will make snowplowing the cemetery easier around Christmas time. He was thanked for doing this for the township.

The new Kaunonen Lake Road Bridge is now open, to the delight of many in attendance. It was suggested that the clerk send County Commissioner Tom Rukavina a letter of thanks for working hard to keep the bridge open and then to be re-built. Many in the township were persistent in conveying this need to the county board. We are grateful to again have easy access to the cemetery from the town hall.

An individual in attendance asked if more info was obtained on the MnDot Road Funding application. Emily had talked to Patty Locken and was told that we would need to show how South Skarp Road is a significant route in our area/region.

Old Business: The Heikkila Road sign has been replaced.

An email was received from SEH Road Engineer, Jason Chopp. He and Phil had met last month to get an estimate on re-building South Skarp Road. After that meeting, Mr. Chopp had a follow up meeting with Mark Gothard from Braun Intertec. Upon inspection they both agreed that soil borings along the road would not provide much value to the township. He stated that the road was built through a swamp and is slowly sinking into the organic soils below. The most basic solution would be to raise the grade of the road (approx. a foot or so) and perhaps place a geogrid material under the class 5 to slow the settlement process. Unfortunately, raising the road will increase the loading weight and further compress the organic soils underneath. His rough estimate to raise the road and add geogrid will cost \$75,000 to \$100,000. This solution would not be permanent and will require long term maintenance as the road continues to slowly sink.

The board was reminded that there was a motion made at the Special Board meeting on August 22 to hire Braun Intertec to perform the soil borings on South Skarp Road. But, after reading the email from and noting that Jason Chopp has changed his mind about the need to perform the boring, Emily stated that we should wait and make a final decision at the October meeting.

We have been informed that St. Louis County will no longer put their road grader or snowplow equipment on South Skarp Road. Equipment could get stuck and also cause further damage to the road. The road remains closed.

Emily will get price quotes from 3 different sign companies to use to warn of the closed road and for barricades.

Improvements are moving forward on Beckman Road: Brushing and gravel will be applied. A larger culvert will be installed on South Skarp near the corner of Damian Road.

The new sign will be placed at the cemetery soon. The location was discussed. It will be placed so that it is visible when coming from both directions on Kaunonen Lake Road near the gate in the upper section.

The tables and chairs were returned in good condition last month.

The Clerk was not able to attend the MAT District 10 Meeting in Grand Lake Town Hall on August 24, 2017.

New Business: None

Correspondence: A hard copy was received from Lakes Gas Company quoting propane at the price of \$.999/gallon for the up-coming season. All other mail was read and filed.

Note: At this point in the meeting, the board and several Waasa residents drove to the new Kaunonen Lake Road Bridge. After a few photos were taken, adjournment took place.

Adjournment: Emily moved to close the meeting at 8:10 p.m. Supported by Mitch.


